- ❖ Qualifications for Board of Champions Membership
 - Willing to accept the responsibility and commitment of Board membership
 - Demonstrates leadership qualities

 - Willing to complete 40 Assets training

- ❖ FYI Board Member terms vary. At the minimum a 1 year commitment is required. Board members can serve up to 3 years. At any given time the board must consist of:
 - 3 people serving for 3 years
 - 2 people serving for 2 years
 - 2 people serving for 1 year

- ❖ FYI Board members are expected to attend monthly meetings and participate in additional committees as needed. (Missing more than 4 meetings will require your resignation.)
